CLUB RULES



CLUB ACCESS

If you attend a Hustle Hut Health (HHH) offering 24-hour operation, and you use a Hustle Hut Health outside of Staffed Hours, you accept and acknowledge that:

- You will not allow any Non-Members into the Hustle Hut Health
- You will not inappropriately use the emergency system. You accept and agree to indemnify us for all costs associated with deliberately using the emergency system in an inappropriate manner.

REFUSAL OF ENTRY

You may be refused entry or asked to leave if you:

- Act or engage in any activity which could cause damage to the gym, the fitness equipment or any item of property at a Hustle Hut Health.
- Do not follow any instruction or direction given to you by Hustle Hut Health Staff concerning use of the equipment or personal conduct
- Act or engage in any activity which causes or threatens harm against Hustle Hut Health or other Members
- Act or engage in any activity which constitutes sexual harassment against Hustle Hut Health Staff or other Members
- Are under the influence of, or suspected to be under the influence of, any intoxicating substance or illicit substance while at any Hustle Hut Health Facility; and/ or consume, or are in possession of, any intoxicating substance or illicit substance while at any Hustle Hut Health.

DRESS CODE

- Members must wear appropriate clothing while using Hustle Hut Health, in the discretion of the Hustle Hut Health Staff. Work clothes, boots and casual clothes that are not sportswear are not permitted
- Members must wear appropriate enclosed sport shoes at all times while using the equipment or fitness area
- Members who do not wear appropriate clothing or shoes may be asked to leave Hustle Hut Health.

HYGIENE

- Members are requested to use towels when using the facilities to maintain hygiene and safety standards
- Towels can be purchased from every Hustle Hut Health

NON-SMOKING FACILITY

- All Clubs are non-smoking facilities
- Members will be asked to stop smoking and may be asked to leave in the event they continue

SAFETY, MAINTENANCE & SERVICE DEMAND

We will at times be required to make changes to our operations and the operations of our Hustle Hut Health for the purposes of safety, maintenance and service demand. This may include:

- Closing off part of the Hustle Hut Health and equipment areas due to safety of maintenance requirements
- Changing operating hours to suit demand.
 Where this occurs, we will endeavour to provide you with adequate and reasonable advance notice.

LOST PROPERTY & PIGEON HOLES

- Pigeon Holes are available for Members to store their personal times
- These Pigeon Holes are not intended to securely store any personal items
- Hustle Hut Health will not take responsibility for any items being lost, damaged or stolen
- Any items of lost clothing or property will be held for two weeks, and then donated to charity if applicable.

USE OF EQUIPMENT

- You must complete an OIP in accordance with contract prior to undertaking your first exercise session or using any equipment at Hustle Hut Health
- You must at all times follow the safe operating procedures and instructions on the equipment and/or as directed by Hustle Hut Health
- You must only use the equipment for its intended purpose/s
- If you cause any damage to the gym, the fitness equipment or any item of property at Hustle Hut Health Facility, you must notify us immediately and we are entitled, at our discretion, to charge you for the costs of repairing the damaged items or, if repair is not possible, replacement of the damaged items.
