In the event of any inconsistency between the terms of the Membership Agreement and the terms of this Guest Pass Agreement, the terms of this Guest Pass Agreement shall prevail to the extent of that inconsistency. Capitalized terms in this Guest Pass Agreement have the same meaning as in the Membership Agreement.

1. Your Guest Pass

By using a Guest Pass to access Hustle Hut Health Facilities, you acknowledge and agree to the following:

- (a) Your guest pass entitles you to a one-time access to the Hustle Hut Health Facilities.
- (b) You are using the Hustle Hut Health Facilities as a guest with temporary access, which may be revoked at any time at our sole discretion.
- (c) You may only access the Hustle Hut Health Facilities during Staffed Hours and may be asked to leave by Hustle Hut Health staff once Staffed Hours end.
- (d) You must abide by the Club Rules (as applicable) at all times while using the Hustle Hut Health Facilities.
- (e) You confirm you are not aware of any medical or physical condition that may be affected or aggravated by exercise or result in illness, injury, or death from using the Hustle Hut Health Facilities. You further confirm you are in good physical condition and have considered any necessary medical advice prior to engaging in exercise of the type you will do while using the Hustle Hut Health Facilities.

- (f) You will be responsible for your own personal use of the equipment provided in the Hustle Hut Health Facilities.
- (g) We implement video and audio surveillance for safety and security reasons. While using any Hustle Hut Health Facilities, you consent to such surveillance and to Hustle Hut Health storing and retaining related recordings.
- (h) You are responsible for the storage and use of your personal items at Hustle Hut Health Facilities. Hustle Hut Health is not liable for any loss, theft, or damage to your personal items.

2. Release & Indemnity

By accessing any Hustle Hut Health Facility under a Guest Pass, you acknowledge and agree that

Risk of Injury

- You acknowledge and accept that while at a Hustle Hut Health Facility or engaging in exercise activities using the equipment, there is a risk of injury, permanent disability, or death.
- Such injury may result from your own actions or from the actions, omissions, or negligence of others, including Hustle Hut Health.

Assumption of Risk

- You understand that although every attempt is made to ensure that Hustle Hut Health Facilities are safe, there are significant and inherent risks involved in using them.
- You assume all such risks and agree that you are attending and using the Facilities entirely at your own risk.

Indemnification

- You agree to indemnify, hold harmless, and release Hustle Hut Health (including its officers, employees, organizers, representatives, and successors), as well as the owners and tenants of Hustle Hut Health Facilities, from and against all claims, liabilities, injuries, losses, or damages you may suffer or incur.
- This includes any losses or damages incurred by a third party, arising from or connected in any way with your attendance at a Hustle Hut Health Facility or your use of any equipment there.
